

## ABOUT CONTRACTOR CASH

Contractor Cash is a rebate program paid direct to contractors for all qualifying purchases made through our authorized distributors. Buy a minimum of 50,000 ft. of any combination of qualifying products during each rebate round to participate. You will be paid in the form of an American Express gift card.

The rebates will run in 3 month increments:

- Round 1: January 1<sup>st</sup> - March 31<sup>st</sup>
- Round 2: April 1<sup>st</sup> - June 30<sup>th</sup>
- Round 3: July 1<sup>st</sup> - September 30<sup>th</sup>
- Round 4: October 1<sup>st</sup> - December 31<sup>st</sup>
