ABOUT CONTRACTOR CASH

Contractor Cash is a rebate program paid directly to contractors for all qualifying purchases made through our authorized distributors. Buy a minimum of 75,000 ft. of any combination of qualifying products during each rebate round to participate. Rebates are not to exceed \$1000 per quarter. You will be paid in the form of an American Express gift card.

The rebates will run in 3 month increments:

- Round 1: January 1st - March 31st
- Round 2: April 1st - June 30th
- Round 3: July 1st - September 30th
- Round 4: October 1st - December 31st

To get paid, you must submit a copy of your invoice from the distributor and the attached form by the dates below. Late submissions may not be accepted.
